under the following terms:

The fee for the stud service must be paid before the time of service in the amount of \$1,200.00.

NOTE: The American Kennel Club takes the position that the owner of the sire is required to sign an application to register a litter certifying only to the fact that a particular dam was bred to the sire identified on the Litter Registration Application form on a specified date of mating, unless there is an agreement signed by all parties concerned in which it specifically set forth that the owner of the sire is not obligated to sign an American Kennel Club Litter Registration Application form until such time as the stud fee has been paid.

The owner of the Dam warrants that this Dam has not been exposed to any stud dog prior to her arrival and that she will be protected from such exposure after her return home. The stud owner will breed the stud dog to the Dam at least twice but preferably three times with a minimum of 24 hours between breedings. If two or more puppies do not result from this breeding, the Dam owner has two (2) options:

A second stud service is available to the Dam at a later heat cycle, by the same stud dog, free of charge within 1 year.

There is not charge for boarding the Dam for the first 3 days, after which the charge will be \$25.00 per day. It is recommended that the Dam owner brings the Dam's own food while boarding. In the event that no food is provided by the Dam owner, a \$5.00 per day fee will be added for feeding the Dam the stud owners food. During this time the Dam will be fed, watered, exercised, and cared for daily by the stud owner. The stud owner agrees to keep Dam confined and inaccessible to all other male dogs until the Dam has been bred and returned to her owner.

OR the Dam may be brought to the home of the stud owner for 3 days for breeding purposes and then return home with the Dam owner each day.

The Dam owner hereby agrees that his or her Dam is cared for and handled by the stud owner without liability on the stud owner's part for loss or damage to the bitch from accidents, injury, disease, theft, fire or other unavoidable causes or injury to persons, other animals, or damage to property caused by Dam when due diligence and care have been exercised by the stud owner.

If need arises, the stud owner will provide veterinary care of the Dam. Except in an emergency, when the Dam owner cannot be contacted, the stud owner will consult with the Dam owner prior to any veterinary intervention. The Dam owner will reimburse the stud owner for any such veterinary expenses.

Dam owner has agreed that Dam is healthy and up to date on all vaccinations (including Kennel Cough) and is willing to show proof of such. Dam owner agrees that Dam will not be sold, traded or given away to third party while carrying puppies.

To insure the owners of the Dam has read and does indeed understand the conditions of this contract as set forth herein, please sign and date below. DO NOT SIGN IF YOU DO NOT UNDERSTAND THIS STUD SERVICE CONTRACT.

In consideration of a Stud price of one thousand two hundred dollars (\$1,200.00), of which is non-refundable. This can be paid by cash, or paypal with 3% extra for paypal fees.
